- Vice President/President-Elect:** Must have been an active member in good standing for at least two years prior to election.

- Treasurer:** Must have been an active or life member in good standing for at least two years prior to election.
- Chief Delegate:** Must have been an active member in good standing for at least two years prior to election.
- Delegate:** Must have been an active member in good standing for at least two years prior to election.
- PTA Caucus Delegate:** Must have been an active member in good standing for at least two years prior to election. Will also serve as chair of the IPTA PTA Special Interest Group.
- Foundation Director or At-Large Board Member:** Must be a member in good standing.
- Special Interest Group Officer:** Must be a member in good standing.

NOMINEE FOR AWARD

- Olive C. Farr Distinguished Service Award:** Include a detailed explanation of how the nominee (PT) meets the following qualifications:
 - Membership (Active) in good standing for at least four consecutive years
 - Demonstrated professional accomplishments
 - Participation in IPTA activities
 - Contribution to the clinical or scholarly growth and advancement of the profession.
- Physical Therapist Assistant Distinguished Service Award:** Include a detailed explanation of how the nominee (PTA) meets the following qualifications:
 - Membership in good standing for at least four consecutive years
 - Demonstrated professional accomplishments
 - Participation in IPTA activities
 - Contribution to the clinical or scholarly growth and advancement of the profession.
- Max Shelton Friend of Iowa Physical Therapy Award:** This award recognizes individuals (or organizations) other than PTs/PTAs for exceptional service to the physical therapy profession in Iowa. Include a detailed explanation of how the nominee meets this criteria.
- Clinical Research Award:** This award recognizes achievement in clinical research in physical therapy. The nominee should be a member who has had the results of research published during the preceding 12 months. The publication must not be the obligatory requirement of an academic degree. Include a detailed explanation of how the nominee meets this criteria.
